

CONSENT TO INSTALLATION OF PUBLIC SAFETY COMMUNICATIONS FACILITIES AT COOK'S BUTTE PARK

I, Leslie Emery, state that I am one of the three children of John G. Emery and Marjorie H. Emery. The other two children are John F. Emery and Walter E. Emery. On April 3, 1975, my parents conveyed to the City of Lake Oswego certain real property, described on the attached Exhibit 1, and now known as Cook's Butte Park. This conveyance included a covenant that the property would not be sold or used for any purpose other than park purposes or public utilities during my parents' lifetimes and the lifetimes of their three children, or the survivor, without their express written consent. My parents are deceased.

I hereby consent to the installation, use, and maintenance of public safety communications facilities on the property, including a communications tower with related structures, equipment and fencing, together with a roadway and underground power line extending to those facilities.

Legal Description of Parcel I

Beginning at the Southwest corner of said Section 16 and running thence North 294.36 feet along the westerly line of said Section 16 to an iron pipe, said iron pipe being the true point of beginning; thence continuing North along said section line, 1670.95 feet to an iron pipe; thence leaving said section line South 89°53'15" East, 1220.00 feet to an iron pipe; thence South 12°33' East, 576.39 feet to an iron pipe; thence South 13°15' West, 239.00 feet to iron rod; thence North 86°24' East, 191.07 feet to an iron rod; thence South 13°15' West, 242.01 feet to an iron pipe; thence South 13°16' West, 461.54 feet to an iron pipe; thence South 81°25'30" West, 156.23 feet to an iron pipe; thence South 81°07'30" West, 1182.69 feet to the true point of beginning, all in Clackamas County, Oregon.
